

Together these complementary technologies provide a complete end-to-end solution of products that contribute to the long life and high functionality of ophthalmic lenses.

The addition of COBURN, which has a 65-year history of manufacturing and selling equipment and consumables for the ophthalmic lens processing laboratory, to the Mitsui Chemicals Group, will enable new technological advancements that combine the strengths of materials and processing equipment to address social issues, such as digitization, automation, and eco-sustainability.
